- 25. Quotations received by fax or through electronic mail shall be sealed-enveloped by the Procuring Entity duly marked as stated in **Para 6** above and all Quotations thus received shall be sent to the Evaluation Committee for evaluation, without opening, by the same date of closing the Quotation.
- 26. The Procuring Entity may extend the deadline for submission of Quotations on justifiably acceptable grounds duly recorded subject to threshold of ten (10) days pursuant to Rule 71 (4) of the Public Procurement Rules, 2008.
- 27. All Quotations must be valid for a period of at least 60 days from the closing date of the Quotation.
- 28. No public opening of Quotations received by the closing date shall be held.

- 33. In case of anomalies between unit rates or prices and the total amount quoted, the unit rates or prices shall prevail. In case of discrepancy between words and figures the former will govern. Quotationer shall remain bound to accept the arithmetic corrections made by the Evaluation Committee.
- 34. The supply of Goods and related services shall be completed within 14 days from the date of issuing the Purchase Order.
- 35. The Purchase Order that constitutes the Contract binding upon the Supplier and the Procuring Entity shall be issued within 7days of receipt of approval from the Approving Authority.
